

Registration/Re-registration Agreement

Please review the information below, initial where applicable, keep a copy for your records, and return the original with your registration paperwork.

Registration Fee/Due Dates for Recruits

For recruits: \$250. There is a \$100 non-refundable deposit that must be paid at time of registration. Balance of \$150 is due by graduation.

Re-registration Fees/Due Dates

For current Young Marines: \$70 if received by September 15, \$100 if received from September 16-25

***Anyone not submitting registration forms and payment by September 25 will NOT be re-registered with the unit**

Report Card/Grade Policy

Young Marines and recruits are required to turn in a report card every quarter. To be deployable, they have to have a minimum 2.0 GPA and no F's. Anyone who falls below a 2.0, has an F, or does not turn in a report card for any given quarter is non-deployable and will need to earn a 2.5 GPA and no F's the following quarter to be deployable again.

Deployable means a Young Marine can participate in unit trips, campouts and other fun activities. Their deployable status does not apply to drill, community service events or parades.

Report cards are due by the end of drill on the dates posted on our unit calendar. If your school has not issued your report card by the dates listed, you are still responsible to notify the staff by the end of drill or you will be considered non-deployable. All report cards are to be emailed to reportcards@glcyoungmarines.org. The dates, as well as the email address, will be posted on the website at all times.

NOTE: If a report card is not received by the following month as stated above, that Young Marine/recruit is non-deployable until the next grading period (if this occurs during the 4th quarter, they are non-deployable the entire summer until after the 1st quarter of the following school year). No exceptions. At that time, he or she must also achieve a 2.5 GPA and no F's the following quarter to be deployable again.

Uniform Policy

Proper uniform or being "squared away" includes all items on the Uniform Checklist and proper haircuts (see "Hair Cuts" below). A uniform checklist is provided on the following page. Young Marines/recruits need to come to drill and other events "squared away" and with all the tools they need. See Performance Objective 2: Essential Subjects Section E.O.1 in the Basic Guidebook for uniform regulations.

The Uniform Checklist was designed to help Young Marines/recruits and parents understand what is required every time the Young Marines/recruit wears his or her uniform. We suggest your Young Marine/recruit (and, parent, if necessary) review this checklist before drill and any event he or she will be in uniform. It might be helpful to keep a copy of the form and use it throughout the year. This will ensure that everyone is prepared.

The unit will no longer let Young Marines/recruits "borrow" something such as a cover, belt, boots, PT uniform, etc. at drill. If your Young Marine/recruit is missing an item, please send money, along with a Supply Order Form, with them to drill so they can purchase the items they need replaced. We have added a summary of the cost(s) for your convenience. (A full explanation of costs can be found on the Supply Order Form. Please use this form whenever you need to order/replace items).

Hair Cuts

We will no longer tolerate Young Marines and recruits coming to drill without proper haircuts. See Section Performance Objective 2: Essential Subjects E.O.2 in the Basic Guidebook for the regulations. If your Young Marine/Recruit does not have a proper haircut, we will send them home and they will receive an unexcused absence until they return with a proper haircut.

For community service events, Young Marines/recruits who show up without proper haircuts or missing uniform items such as a cover, boot blouses, etc. will not be permitted to participate in the event and will not receive community service hours for that event as well.

PT GEAR

PT Gear consists of red unit t-shirt and black, knee length, black mesh shorts for summer and red unit shirts and red unit sweatshirt/pants. The shorts must be solid black with no stripes. Young Marines/recruits are not permitted to wear "other items." You will need to purchase the shorts on your own. We have an ample supply of the red sweatshirt/sweatpants in our supply room for you to purchase. All Young Marines and recruits must have these items at every single drill.

haircut, he or she will not be able to participate in the activity and will not		
receive community service hours for the event.
